However, Deemed to be Universities are still required to seek prior approval/recommendation/ NOC of AICTE for offering of such programmes in ODL and/or Online mode.
- (IV) Programmes under the ambit of the Regulatory Authorities have been considered on the basis of communication/recommendation received from respective Regulatory Authority. The HEI shall abide with the conditions such as number of seats, valid academic year etc. mentioned in the relevant Regulatory Authority letter.
- (V) The HEIs shall ensure the compliance of entry level qualification, mode of admission, duration of programme (minimum & maximum) and number of credits as per UGC Notification on Specification of Degrees 2014, UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and other instructions/notices issued by UGC and other statutory/ regulatory bodies from time to time.
- (VI) Provision stipulated under Regulation 3(B)(a) of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 is as under:-
 - ".....a Higher Educational Institution having National Assessment and Accreditation Council (NAAC) valid score equal or more than 3.26 or having rank in Top 100 in University category of National Institutional Ranking Framework at least twice in three greening cycles shall be permitted to enroll International Learners also..."

- (IX) The list of online eligible HEIs which have submitted the affidavit to ensure compliance of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendments and have been found complying with above mentioned provisions for academic year 2024-25, academic session October, 2024 (revised from July-August, 2024) is appended herewith.
